  - Marginoftheleftshould be1.5inches, withtop, bottom, and righthandmarginatlinch.
  - Footnoting and citation should be based preferably on JILI (w.ili.ac.in), 10' Times New roman Style, with single spacing and justified alignment. The style of referencing must be consistent throughout.
