Eligibility and Educational Qualification

1. <u>Professor (On Deputation):- University School of Education (USE) &</u> <u>University School of Mass Communications (USMC)</u>

Eligibility:

1. Holding analogous posts or Teaching Faculty working under the Central Government or State Governments or Union territories or Public Sector Undertakings or industry (owned by Government) or Universities or Semi-Government or Statutory or Autonomous organizations.

And

2. (A) (i) An eminent scholar having a Ph.D. degree in the concerned/allied/relevant discipline, and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in the peer-reviewed or UGC-listed journals and a total research score of 120 as per the criteria given in Appendix II Table 2 of UGC Regulation 2018.

(ii) A minimum of ten years of teaching experience in university/college as Assistant Professor/Associate Professor/Professor, and / or research experience at equivalent level at the University/National Level Institutions with evidence of having successfully guided doctoral candidate.

OR

(B) An outstanding professional, having a Ph.D. degree in the relevant/allied/applied disciplines, from any academic institutions (not included in A above) / industry, who has made significant contribution to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience.

2. Associate Professor (Regular) in University School of Education (USE):

Eligibility:

(i) A good academic record, with a Ph.D. Degree in the concerned/allied/relevant disciplines.

(ii) A Master's Degree with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).

(iii) A minimum of eight years of experience of teaching and / or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy five (75) as per the criteria given in Appendix II, Table 2 of UGC Regulation 2018).

3. Assistant Professor (Regular) in University School of Education (USE):

Eligibility (A or B):

Α.

i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading System is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.

(ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil./Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-

- a) The Ph.D. degree of the candidate has been awarded in a regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/seminars sponsored/funded/supported by the UGC / ICSSR/ CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned.

Note: NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

OR

B. The Ph.D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

Note: The Academic score as specified in Appendix II (Table 3A) for Universities, as per UGC Regulations 2018, shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the interview.

Note : As per UGC notification No. F.9-42/2023(PS/Misc.) dated 06.07.2023, it is mentioned clearly that NET/SLET/SET is the minimum requirement for the direct recruitment of an Assistant Professor for those who do not have a Ph.D. degree. But holders of Ph.D. degrees awarded as per UGC Regulations and its amendments are exempted from NET/SLET/SET and thereby eligible for direct recruitment to the post of Assistant Professor.

<u>Eligibility and Educational Qualification For Teaching Faculty in University School of</u> <u>Architecture & Planning (USAP)</u>

4. Professor (on Deputation) in USAP

Holding analogous posts or Teaching Faculty working under the Central Government or State Governments or Union territories or Public Sector Undertakings or industry (owned by Government) or Universities or Semi-Government or Statutory or Autonomous organizations.

AND

Bachelor's Degree in Architecture or equivalent to B. Arch and Master's Degree in Architecture or in allied subjects of Architecture with minimum 60 per cent Marks at either level, and Fourteen years experience in teaching/ research/ professional work out of which a full-time teaching experience of minimum five years

OR

Nineteen (19) years of professional experience.

Desirable: Ph.D. in Architecture.

5. Associate Professor (Regular) in USAP

Bachelor's Degree in Architecture or equivalent to B. Arch. and Master's Degree in Architecture or in allied subjects of Architecture with minimum 60 per cent Marks at either level, and Eight years experience in teaching/ research/ professional work out of which a full-time teaching experience of minimum three years

OR

Thirteen years of professional experience

6. Assistant Professor (Regular) in USAP

Bachelor's Degree in Architecture or equivalent to B. Arch. with minimum 60 per cent marks and three years of relevant professional experience.

OR

Bachelor's Degree in Architecture or equivalent to B. Arch. and Master's Degree in Architecture or in allied subjects of Architecture with minimum 60 per cent Marks at either level and one year of relevant professional experience.

Note:-

1. The equivalent qualification shall mean any such qualification as recognized by the Council of Architecture for registration as an Architect under Section 25 of the Architects Act, 1972.

2. As per COA norms 2019, only candidates registered with Council under the provisions of the Architects Act, 1972 shall be eligible for the posts of Core faculty.

IMPORTANT NOTE FOR CANDIDATES:

- 1. The Number of posts are indicative and may vary as per the requirement of the University.
- 2. The Candidates are advised to visit University website <u>www.ipu.ac.in</u> time to time for any updates i.e. modifications, if any, pertaining to this advertisement like qualifications, interview dates, requisite documents *etc.* will be uploaded and updated on University website.
- 3. This advertisement must be read with General terms & conditions enclosed alongwith this advertisement.
- 4. In case of large number of applications, University may conduct written examination or candidates can be shortlisted based on their Academic Research Score/ Experience etc. as decided by the University.
- 5. All candidates are requested to ensure submission of duly filled in Appendix-II Table-II for the post of Professor and Associate Professor and Appendix-II Table-3A in case of Assistant Professor in the Universities. In absence of above appendix as applicable, the application of candidate will be summarily rejected and no further correspondence will be entertained. The Academic score as specified in Appendix II (Table 3A of UGC Regulations No. F.1-2/2017(EC/PS) dated 18/07/2018) (for Universities) shall be considered for short-listing of the candidates for interview.
- 6. The selected candidates on regular basis will be placed on probation for a specific period as per provision under Act/ Statute of the University.
- 7. The shortlisted candidate will be called for Document Verification on scheduled date and time as informed by the University on University website as well as through e-mail. At the time of Document verification, candidates should carry all their original documents and testimonials for verification along with a hardcopy of duly filled-in application form submitted in online mode with a copy of all educational qualifications, reprints of research publications, teaching/ working experience certificates/ last pay drawn etc for submission.
- 8. Eligibility conditions as per AICTE / UGC etc. from time to time shall be applicable. Relaxation in qualification / age for SC/ST/OBC/EWS/PwD shall be as per UGC norms as applicable. The OBC candidates must be in possession of Non Creamy Layer certificate issued during current financial year along with his/ her caste certificate issued by Delhi.

- 9. In case of Contract appointment, the initial appointment will be for a period of one year which may be extendable subject to performance and the requirement of the University. The contract appointment may also be terminated with one month notice on joining of regular faculty.
- 10. Appointment on Deputation will be initially for a period of 03 years which may be extendable subject to performance and the requirement of the University.
- 11. On Regular appointment, period of probation will be as per University norms.

General Instructions for Candidates

- 1. The numbers of posts are tentative and may vary as per requirement of University.
- 2. Update (if any) pertaining to this advertisement, to fill up referred post, will be uploaded on university website <u>www.ipu.ac.in</u> It is in the interest of the applicant to visit the university website regularly to their convenient.
- 3. All applicants who are presently employed in Government/Semi-Govt./ Public Sector Undertaking/University/Recognized Educational Institute etc. should submit through proper channel enclosing a certificate from the Government organization stating that no Vigilance or Disciplinary case is pending or contemplated against them and also submit a no objection certificate from present employer at the time of interview. Failure to provide the same shall make them ineligible for consideration to the post.
- 4. The educational qualification(s), age, experience and other conditions of eligibility as stipulated above against the post shall be determined as on the closing date of receipt of applications.
- 5. Fulfillment of conditions of minimum qualification shall not necessarily entitle any applicant to be called for further process of recruitment.

6. Reservation Benefits:

- (i) Reservation benefits will be available to the SC/ST/OBC/EWS candidates in accordance with the extant Instructions / Orders / Circulars issued from time to time by the Govt. of NCT of Delhi/DOP&T, Govt. of India.
- (ii) Candidates who wish to be considered against reserved vacancies must be in possession of relevant certificates (SC/ST/OBC & Non Creamy layer/EWS) issued by the competent/notified authority (in prescribed format) on or before the last date of submission of application, i.e., 10th Dec., 2021 otherwise their claim for any category will not be entertained and their applications will be considered against Un-reserved (UR) category vacancies, if eligible otherwise.
- (iii) Only OBC (Delhi) candidates notified by Govt. of NCT of Delhi vide letter/order No. F.19(10)/2001/SIII/Pt.File/2278-2285 dated 27/07/2007(Annexure-I) and No. F.19(01)/2012/S.IV/1241-1258 dated 28/07/2016 (Annexure-II) will be given the benefit of reservation under OBC category. This has further been clarified by Services Department, Govt. of NCT of Delhi Vide its Office Memorandum No.F.19(02)/2011/S.IV/Vol.I/856 dated 31/05/2021 (Annexure-III). OBC (Outside) candidates will be treated as Un-reserved candidate. The OBC candidates must be in possession of non-Creamy layer certificate, along with his/her caste certificate.
- (iv) Only following two types of certificates will be accepted as valid certificates for grant of benefit of reservation to OBCs:- (A) OBC certificate (Delhi) issued by the Revenue Department of GNCT of Delhi, on the basis of a old certificate issued to any member of individual's family from GNCT of Delhi. (B) OBC certificate issued by a competent authority outside Delhi to a person belonging to a community duly notified as OBC by GNCT of Delhi. This certificate should have mandatorily been issued on the basis of OBC certificate issued by Govt. of NCT of Delhi to a family member of the concerned person who had been residing in Delhi before 08/09/1993.
- . The copies of all Educational and Professional Qualifications, Experience Certificates, Caste Certificate/ PWD certificate/ Ex-Serviceman certificate (in case claiming benefit of reservation, fee exemption & age relaxation etc.) must be submitted at the time of Document verification/ Interview.

- 8. In case of large number of applicants, University reserves the right to shortlist applicants in any manner as may be considered appropriate and no reason for rejection shall be communicated.
- 9. The University reserves the right to fill or not to fill post advertised, no correspondence, whatsoever, will be entertained from the candidates regarding postal delays, conduct, result and reason for not being shortlisted.
