IMPORTANT NOTICE

MANAGEMENT QUOTA ADMISSION- ACADEMIC SESSION 2025-26

- The relevant Sections of the Delhi Professional Colleges or Institutions (Prohibition of Capitation Fee, Regulation Admission, Fixation of Non-Exploitive Fee and other Measures to Ensure Equity & Excellence) Act, 2007 (Delhi Act 8 of 2007) and rules made there under and other important orders relating to management quota admission are reproduced below for the information of all the stakeholders:-
 - (a) Section 12 (1) (a) of the Delhi Professional Colleges or Institutions (Prohibition of Capitation Fee, Regulation Admission, Fixation of Non-Exploitive Fee and other Measures to Ensure Equity & Excellence) Act, 2007 (Delhi Act 8 of 2007), states that in every Institutions, except the Minority Institutions subject to the provisions of this Act, 10% of the total seats in an unaided Institution shall be allocated as Management Seats.
 - (b) Section 13 of the Delhi Professional Colleges or Institutions Act, 2007 states that "An institution shall, subject to the provisions of this Act, make admission through a Common Entrance Test to be conducted by the designated Agency, in such manner, as may be prescribed: Provided that the Management Seats may be advertised and filled up, from the candidates who have qualified the Common Entrance Test, by the Institution in a transparent manner based on the merit of the Qualifying Examination".
 - (c) The Govt. of NCT of Delhi in exercise of powers conferred by Section 23 of the Act, 2007 has made Delhi Professional Colleges or Institutions Rules 2007. The details of Rules 8(2)(a) relating to management quota admission alongwith explanation have also been made available in the Para 6.2 of Chapter-6 of the UG/PG Admission Brochure 2025-26 for the information of all the stakeholders.
 - (d) Directorate of Higher Education, Govt. of NCT of Delhi Order No. DHE-4(4)/GGSIPU/2019/4674-76 dated 22.09.22 vide which directions were issued for online registration by the prospective candidates.
 - (e) The Hon'ble High Court of Delhi in the LPA No. 563-2023 and CM Appeal No. 37179/2023, 37180/2023, 37181/2023 in the matter of VIPS versus Govt. of NCT of Delhi and Anr. had pronounced Judgment on 04.08.2023 and subsequently on the application of petitioner in CM Appeal 40286/2023 in LPA 563/2023 issued amendment order dt 07.08.2023. Para 9 of the order dated 07.08.2023 of the Hon'ble High Court of Delhi is re-produced below:
 - Para 9 With regard to first prayer seeking modification in Para-34 of the Judgment, this court finds that though this prayer is not maintainable, however, in view of the averments made therein, we hereby clarify that sub-clause (ii) of para-34 of the judgment shall be read as under:
 - "(ii) Prospective students can apply online on the portal of the institute as well as off line (in the prescribed form downloaded from the website of the college against receipt issued from the college) against available seats under management quota."

- (f) Rules 8(2)(a)(ii) notified by the Govt. of NCT of Delhi makes in mandatory for the affiliated institutes/colleges to advertise Admission Notice Advertisement for Management Quota Seats in atleast two leading daily newspapers, one in Hindi and the other in English in addition to displaying the same on the institutions/colleges website and the Institution's notice board kept in conspicuous place.
- (g) During the Proceding of Hearing No. IX of Admission Regulatory Committee (ARC) held on 01.08.2024, the ARC had issued directions that no institute shall charge more than Rs.2500/- (nonrefundable) for participation under MQ admissions, irrespective of the number of courses applied by the student.
- (h) It is also mandatory that the Admission Notice Advertisement shall be displayed at least fortnight before the last date of closing of admission for the concerned course in the University and the said Admission Notice Advertisement must contain following information:
 - i. Starting date of online management quota registration.
 - ii. Closing date of online management quota registration.
 - iii. Information about the facility of downloading of management quota application forms from the website of the Institute for the information of prospective applicants.
 - iv. Other relevant information as mentioned in Rule 8(2) (a)(ii) of Rule,2007.
 - v. Information relating to URL specifically for making online application including facility of downloading management quota application form and website on which other information relating to Management Quota Admissions 2025-26 are available.
 - vi. MQ registration fees- Rs.2500/- (non-refundable) for participation under MQ admissions, irrespective of the number of courses applied by the candidate.
- 2. In view of the Judgment pronounced on 04.08.2023 and subsequent order dated 07.08.2023 in the LPA 563/2023, the Affiliated Institutes/Colleges are hereby directed to ensure compliance of the Orders of Hon'ble High Court and compliance of the Delhi Professional Colleges or Institutions (prohibition of Capitation Fee, Regulation of Admission, Fixation of Non-Exploitative Fee and Other Measures to Ensure Equity and Excellence)Act, 2007 and the Rules notified there under during the Academic Session 2025-26.
- 3. All the Affiliated Institutes/Colleges are advised to keep online portal open 24x7 including on Saturdays, Sundays and holidays for registration by the prospective candidates and Application Form should be designed in such a way that it captures all the relevant information to prepare rank order merit list as per the enclosed Performa, which is required to be prepared immediately for display on portal/ website within two days of closing date of application.
- 4. It is for information of all the Affiliated Institutes/Colleges that the last date of closing of admission for the concerned course in the University for the purpose of implementing Rules 8(2)(a)(ii) will be intimated by the University to plan schedule of management quota admission by the Affiliated Institutes/Colleges.
