# MINUTES OF 22<sup>ND</sup> MEETING OF FINANCE COMMITTEE OF GGS INDRAPRASTHA UNIVERSITY HELD ON 24<sup>TH</sup> SEPTEMBER, 2008

The 22<sup>nd</sup> meeting of the Finance Committee was held in the Chamber of Hon'ble Vice Chancellor, Guru Gobind Singh Indraprastha University on 24.09.2008 at 3.30P.M. The meeting was attended by the following:-

Prof. K.K. Aggarwal, Chairman, Finance Committee welcomed the Members of the Finance Committee. The record of discussion and the decisions taken are as follows:

Agenda Item No. 22.01: Confirmation of the Minutes of 21<sup>st</sup> Meeting held on 30.04.2008.

The Members of the Finance Committee confirmed the Minutes of the  $21^{st}$  Meeting held on 30.04.2008.

Agenda Item No. 22.02: Action Taken Report on the proceedings of 21<sup>st</sup> meeting of Finance Committee held on 30.04.2008.

Action Taken Report on the proceedings of 21<sup>st</sup> meeting of Finance Committee held on 30.04.2008 was noted by the Members.

Agenda Item No. 22.03: To consider the Revised Estimates 2008-2009 and Budget Estimates 2009-2010 of G.G.S. Indraprastha University, Kashmere Gate, Delhi

- \* The Committee accorded its approval for the Revised Estimates 2008-2009 and Budget Estimates 2009-2010.
- \* The Committee was highly appreciative of the working of the university in achieving academic excellence in general and maintaining sound financial



health and complete transparency in accounts in particular. The Committee rather felt that notes on academic & professional growth and/or initiations of the university should accompany the budget for full appreciation of the budgetary proposals.

\* The Committee felt that it may be desirable that the accounts are audited by the Chartered Accountant in addition to Govt. audits to give university its desired financial autonomy. Only Govt. audits may force the University to adhere to Govt. rules strictly all the time, which may be counter productive to growth & excellence at times.

Agenda Item No. 22.04: To consider the annual accounts for the financial year 2007-2008 of G.G.S. Indraprastha University, Kashmere Gate, Delhi

The Committee approved the annual accounts for the financial year 2007-08 of GGSIP University.

It is suggested by the Secretary(Education) that a part of the interest earned out of the corpus fund may be set aside for creation of Research Chairs in the University. This proposal may be put up to the Govt. for approval as it will entail minor deviation in the Pattern of Assistance.

Agenda Item No. 22.05: To consider the annual accounts of C.P.F. Trust of G.G.S. Indraprastha University, Kashmere Gate, Delhi for the financial year 2007-2008.

The Committee approved the annual accounts of C.P.F. Trust of G.G.S. Indraprastha University for the financial year 2007-08.

Agenda Item No. 22.06: To consider the annual accounts for the financial year 2007-2008 of Indira Gandhi Institute of Technology, Kashmere Gate, Delhi.

The Committee approved the annual accounts for the financial year 2007-08 of Indira Gandhi Institute of Technology.



## Agenda Item No. 22.07: To consider the introduction of Welfare Schemes for the Employees of GGSIPU.

The Committee approved Scheme a(i) & a(ii) as proposed. The Committee also approved Scheme a(iii) with the suggestion that the amount of scholarship may be Rs.10,000/- per annum for boys and Rs.12,000/- per annum for girls. The Committee also approved the proposal (b) as proposed. Regarding proposal (c), the Committee was of the view that the scheme needs more in depth study, so it may be deferred for now.

To meet the expenditure of such Welfare and Allied Schemes, the Committee proposed creation of Vice Chancellor's benevolent fund. The modalities to mobilize funds under this Head may be worked out by the University.

## Agenda Item No. 22.08: To consider creation of posts of Security Supervisor and Sanitary Inspector.

The Committee approved three posts at supervisory level in the grade of Rs.5500-175-9000/-. The other conditions remaining the same as proposed. The said supervisory posts may be used to supervise the work of security as well as sanitary agencies.

### Agenda Item No. 22.09: To consider the introduction of a Pension Scheme for the Employees of GGSIPU.

Some suggestions were made by the Members for further detailed study by the Controller of Finance. The Committee was of the view that this proposal may be deferred for now.

### Agenda Item No. 22.10: To consider the Creation of Class IV posts.

The Committee suggested that instead of creating Class IV posts, the same should be outsourced as and when required.

Agenda Item No. 22.11: To consider the Grant of pay scale of Rs.5500-175-9000 to General Assistants/Head Clerks/Asstt. Wardens, Sr. Stenographer-cum-DEOs and Technical Assistants in the University.

The proposal being in conformity with GNCTD, the Committee approved the same.

The Committee Members were apprised of the Govt. of Delhi's notification for implementation of Sixth Pay Central Civil Services recommendations being implemented in the University.

Agenda Item No. 22.14: Promotion Scheme for Driver-cum-Motorcycle Messengers.

As an additional agenda, with the permission of the Chair, the said item was placed on the table. The Committee decided that the proposal may be approved in accordance with the Govt. of Delhi's Scheme.

The meeting ended with a Vote of thanks to the Chair.
