The teams holding the RANK 1 - 20 are hereby required to give their preference of the moot they want to attend in the academic year 2017-18.

The selected moots are to mailed to e-mail id : mcs.uslls@gmail.com
Deadline : 15th September, 2017 till midnight

The team are required to give their preference in descending order for the National and International Moot.

NOTE:

- 1. Teams are urged to do independent research regarding moots they wish to opt for.
- 2. Once a moot has been allotted, keep checking online from time to time for registration information. Teams are entirely responsible to ensure that they register themselves.
- 3. Teams will be allotted two moots for the entire academic year. The preference should be given by the team as per following rules:
 - (a) In each category the preference should be given in descending order of preference.
 - (b) If a team is giving preferences for international moots, then the second preference can be from either Tier 1 or Tier 2. For e.g. if a team opts for Stetsons International Moot court then they can opt only one national moot either from tier 1 or tier 2. Further, if combination comes to be -Stetsons+ K.K.Luthra Moot Court no additional national moot court shall be awarded in such a case.
 - (c) In case if a team decides only to do National Moots in the academic year, it should give the preference of one moot each from Tier 1 and Tier 2. For eg. if a team opts for K.K. Luthra Moot Court from tier 1 then they can opt only one from tier 2. For E.g K.K.Luthra+ P.N. Bhagwati Moot Court Competition Moot Court . Two moots from the same Tier will not be allotted.
- 4. Before giving the preference the teams should duly ensure the continuance of the said moot competition. If the moot given in preference is discontinued, the teams shall not be allotted a new moot.
- 5. Ranks 21 -39 will choose from the pool of remaining moots only after the Ranks above have been allotted their respective preferences.
- 6. Any dispute arising shall be resolved by Convener, MCC in consultation with Dean, USLLS.
